RESOLUTION NO. 2026-16

A RESOLUTION OF THE CITY OF TRENTON, GILCHRIST COUNTY, FLORIDA, ADOPTING THE TENTATIVE LEVYING OF AD VALOREM TAXES FOR THE CITY OF TRENTON, GILCHRIST COUNTY, FLORIDA FOR FISCAL YEAR 2026-2027; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Trenton, Gilchrist County, Florida on September 14, 2026, adopted a Fiscal Year Tentative Millage Rate following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the City of Trenton, Gilchrist County, Florida held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within the City of Trenton, Gilchrist County, Florida has been certified by the County Property Appraiser to the City of Trenton, Florida as \$122,395,111.00.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TRENTON, GILCHRIST COUNTY, FLORIDA, that:

Section 1. The FY 2026-2027 operating millage rate is 3.6701 mills, which is equal to or more than the rolled-back rate of 3.6701 mills and represents a change of 0 %.

Section 2. The voted debt service millage is 0.

Section 3. This resolution shall take effect immediately upon its adoption.

RESOLUTION NO. 2026-17

**A RESOLUTION OF THE CITY OF TRENTON, GILCHRIST COUNTY, FLORIDA
ADOPTING THE TENTATIVE BUDGET AND APPROPRIATIONS FOR THE
FISCAL YEAR 2026-2027.**

WHEREAS, The City of Trenton, Gilchrist County, Florida on September 14th, 2026, held a public hearing as required by Florida Statute 200.065;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TRENTON, GILCHRIST COUNTY, FLORIDA as follows:

Section 1. The City of Trenton, Gilchrist County, Florida sets forth the appropriations and revenue estimate for the “General Fund” Budget for Fiscal Year 2026-2027 in the amount of \$1,981,472.00.

Section 2. The City of Trenton, Gilchrist County, Florida sets forth the appropriations and revenue estimate for the “Community Redevelopment Fund” Budget for Fiscal Year 2026-2027 in the amount of \$406,395.00.

Section 3. The City of Trenton, Gilchrist County, Florida sets forth the appropriations and revenue estimate for the “Enterprise Fund” Budget for Fiscal Year 2026-2027 in the amount of \$ 1,850,720.00

Section 4. The Fiscal Year 2026-2027 Tentative Budget be adopted.

Section 5. This resolution shall take effect immediately upon its adoption.
